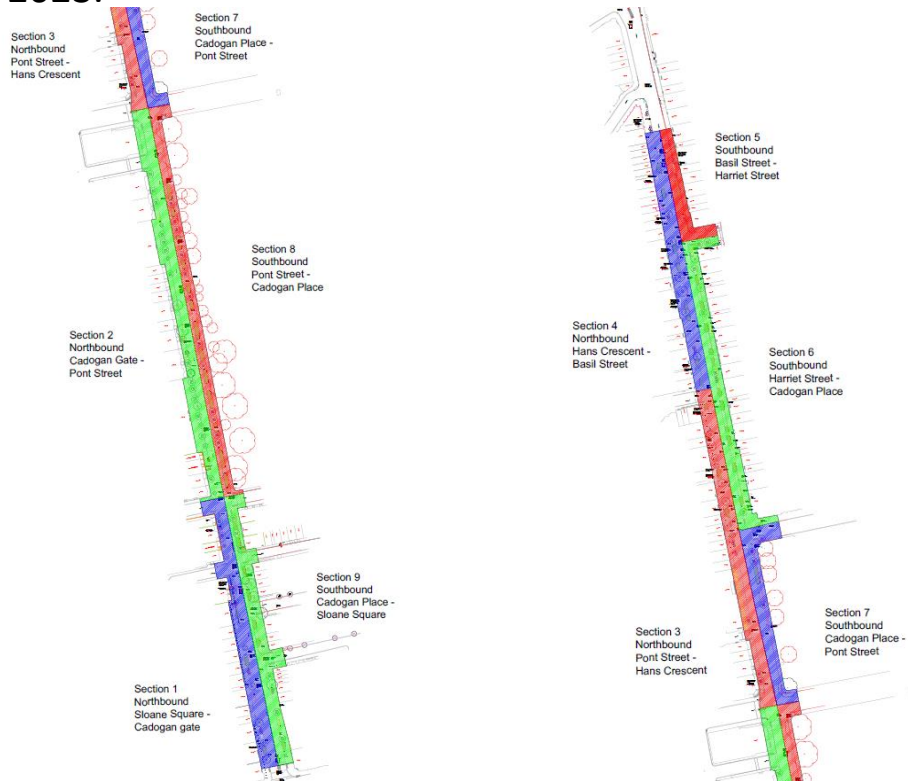

# Utility Diversion Works – Sloane Street, London SW1X

From 1 September 2022, Reach Active will be excavating Sloane Street to divert key utilities in preparation for the wider transformation of the street. From September 2022 to April 2023, work will only take place on the west/ northbound side of the street in the footway and carriageway. Below is the indicative timetable, together with two graphics showing the respective sections/phases. No work will take place in front of retail premises between 14 November 2022 and 2 January 2023.

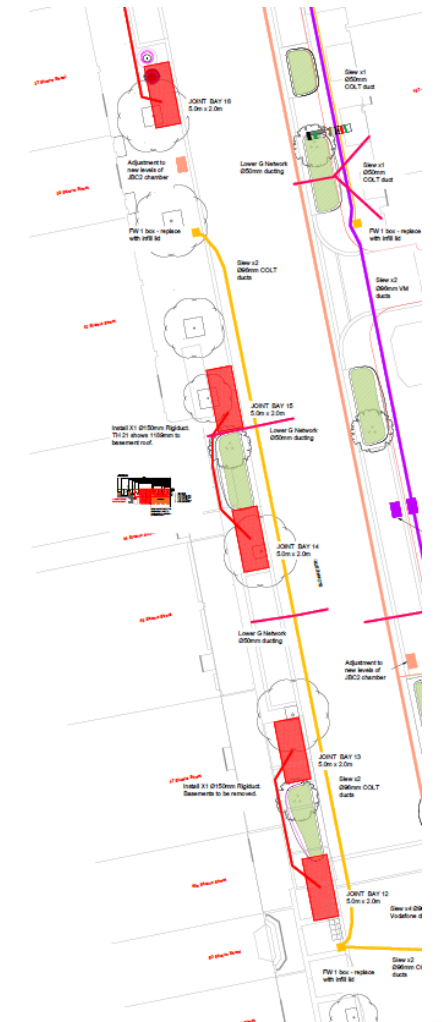
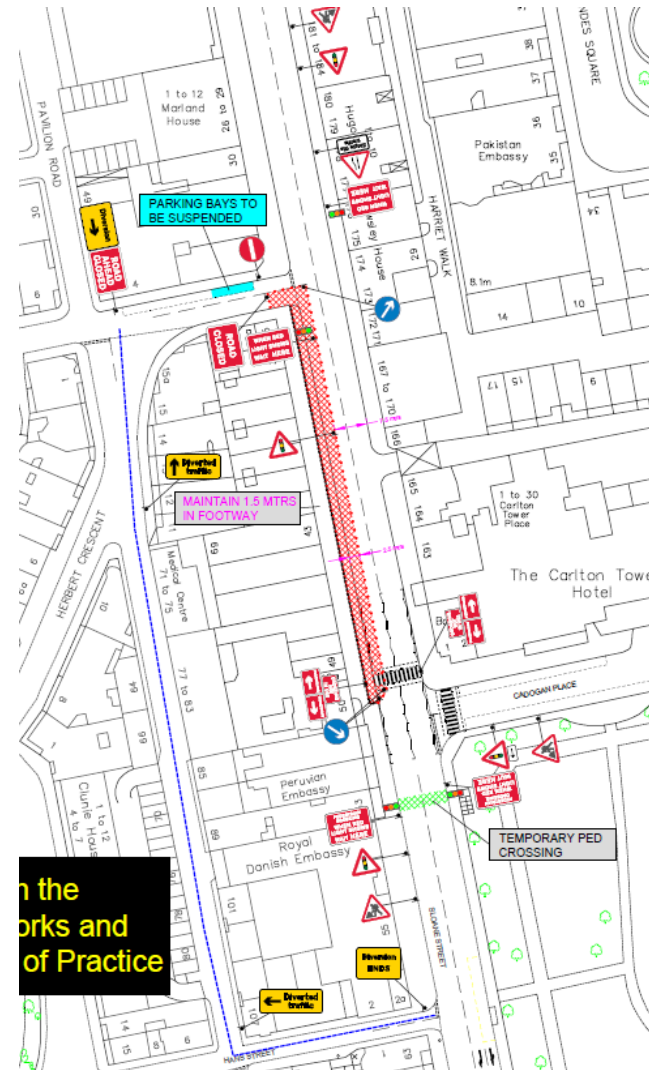

## Traffic Management for Northbound Works

Utility diversion works for the northbound carriageway (west side) will require traffic management comprising of a lane closure and footway narrowing. Temporary traffic signals will be used for works around the Pont Street junction.

Temporary pelican crossings will also replace zebra crossings that will need to be suspended during the works.

The example on the right covers works under Section 3a, which is programmed for September and October 2022. The nearside (northbound) lane will be closed to provide a working lane for Reach Active's works. The footway remains open but is narrowed to a minimum of 1.5m.
